

**RESOLUTION NO. 10122022B**

**A RESOLUTION PROVIDING FOR THE TEMPORARY CLOSURE OF PUBLIC RIGHTS OF WAY, THOROUGHFARES, OR PUBLIC ACCESS ROADWAYS, ON NORTH MARSHALL STREET IN THE FULL 400 AND 500 BLOCKS THEREOF IN THE CITY OF CHAPMAN, KANSAS FOR THE TIMES AND DATES SPECIFIED HEREIN.**

**BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF CHAPMAN, KANSAS:**

**WHEREAS**, the City of Chapman, Kansas through the Governing Body is empowered to regulate street closings and parking in public thoroughfares for public events upon proper request; and,

**WHEREAS** the Governing Body may, by majority vote, declare certain closures or use limitations for such public events; and,

**WHEREAS**, the Governing Body has received a request for temporary closure by a local resident or group for street closure for a civic event identified an Trunk or Treat to be held on or about city property, specifically a public street and common area, and deems it appropriate to allow for a temporary closure to support a local festival activity in the City of Chapman, Kansas.

**NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF CHAPMAN, KANSAS:**

1. The Governing body hereby finds that a temporary street closure along the full 400 and 500 blocks of North Marshall Street in the City of Chapman, Kansas, should be granted on streets and certain public property identified in paragraph 2 of this resolution.
2. The exemption shall apply only to a clearly defined, fenced, or marked and secure area of public roadway, common areas, and public property along and on the full 400 and 500 blocks of North Marshall Street within the city limits of the City of Chapman, Kansas. Such defined area and the surrounding security barriers shall be approved in advance by the Chapman Police Chief.
3. The exemption for the area along and on the full 400 and 500 blocks of North Marshall Street within the city limits of the City of Chapman, Kansas shall be allowed on October 31<sup>st</sup>, 2022, from three o'clock (3:00) p.m. until eight o'clock (8:00) p.m., at which time such temporary street closure shall expire by its own term.

4. When signs are erected giving notice thereof, the various rights of way, thoroughfares, and public access roadway along and on the full 400 and 500 blocks of North Marshall Street within the city limits of the City of Chapman, Kansas, shall be closed to all public vehicular traffic, except for any participant vehicles in the Trunk or Treat event during the period on October 31<sup>st</sup>, 2022 from three o'clock (3:00) p.m. until eight o'clock (8:00) p.m., and related public improvements in that area adjacent to said roadway, **all illustrated on the map attached hereto and incorporated by reference labelled as EXHIBIT A.** Such closure shall apply to all members of the general public with the exception of those attending the Trunk or Treat event, and those staff and volunteers conducting the event, Chapman City Staff, and Chapman Police Department. The Director of Public Works and/or the Chapman Police Department are hereby authorized to install appropriate signs and barricades to put into effect the street closure set forth in this resolution.
